Everyone else will be in the B group, unless they ask to be in the A group. Wayne will e-mail everyone what Class they are in. There will also be awards handed out to the best score every quarter to the highest score. For example, January, February, March – 1<sup>st</sup> quarter – with awards given the first meeting in April.
